- Industry may seek assistance/guidance of Popatrao Kisanrao Thorat College faculty members in product/process modification, modernization, trouble shooting, etc.
- Would allow the industrial visits of students for half/full day to provide them with an exposure to various equipment, instrument, etc.
Industry may showcase its business activities at the seminar/workshop/conference, etc. at Popatrao Kisanrao Thorat College.

- Industry may provide library, internet, and computational facilities to Popatrao Kisanrao Thorat College
- In any of the activities mentioned above, wherever financial aspects are involved, amount, payment conditions, etc. would be spelt out clearly before starting the activity.

Purpose of MoU
